## Form of contract Agreement

  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications:
  - (d) the General Conditions of Contract;
  - (e) the Specification Condition of Contract;
  - (f) the Performance Security; and
  - (g) the Entity's Notice of Award.

- 3. In consideration of the payment to be made by the Entity to the Supplier as hereinafter mentioned, the Supplies hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 2. The Entity hereby covenants to pay the Supplier in considerations of the execution and completion of the Goods, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
