


## CONTRACT AGREEMENT

THIS AGREEMENT, made this 20<sup>th</sup> day of JUNE, 2024 between the Local Government Unit of Tinglayan represented by **HON. SACRAMENT S. GUMILAB** – Municipal Mayor of Tinglayan, hereinafter called the “Entity” and **RJAC CONSTRUCTION, TRUCKING & EQUIPMENTS RENTAL CORPORATION** represented by **ARMAND B. ASPA** – Authorized Representative hereinafter call the “Contractor”

WHEREAS, the Entity is desirous that the Contractor execute to **CONSTRUCTION OF MANPOWER DEVELOPMENT CENTER** with an appropriation amount **P 9,447,243.20** hereinafter called “the Works” and the Local Government Unit of Tinglayan has accepted the Bid in the amount of **NINE MILLION FOUR HUNDRED THREE THOUSANDS AND TWO HUNDRED NINETY NINE AND EIGHTY EIGHT CENTAVOS (PhP. 9,403,299.88)** by the Contractor for the execution and completion of such works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Condition of Contract hereinafter referred to.
2. The following documents as required by the revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, to viz.:

- (a) General and Special Condition of Contract;
  - (b) Drawing/Plans;
  - (c) Specifications;
  - (d) Invitation to Apply for Eligibility and to Bid;
  - (e) Instructions to Bidders;
  - (f) Bid Data Sheet;
  - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
  - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (i) Eligibility requirements, documents and/or statements;
  - (j) Performance Security;
  - (k) Notice of Award of Contract and the Bidder's conform thereto; and
  - (l) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **RJAC CONSTRUCTION, TRUCKING & EQUIPMENTS RENTAL CORPORATION agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of NINE MILLION FOUR HUNDRED THREE THOUSANDS AND TWO HUNDRED NINETY NINE AND EIGHTY EIGHT CENTAVOS ~~(PhP. 9,403,299.88)~~ of such other sums as may be ascertained, RJAC CONSTRUCTION, TRUCKING & EQUIPMENT RENTAL CORPORATION agrees to commence the work - CONSTRUCTION OF MANPOWER DEVELOPMENT CENTER in accordance with his/her/its Bid.

4. The Local Government Unit of TINGLAYAN agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
