CONTRACT AGREEMENT

THIS AGREEMENT, made this 15th day of March, 2025 between the Local Government Unit of Tinglayan represented by HON. SACRAMENT S. GUMILAB - Municipal Mayor of Tinglayan, hereinafter called the "Entity" and ATANCHAN BUILDERS CORPORATION represented by Mr. Nestor G. Ao-as- Manager hereinafter call the "Contractor";

- (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conform thereto; and
- (l) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>ATANCHAN BUILDERS CORPORATION agrees that</u> additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
