CONTRACT AGREEMENT

THIS AGREEMENT, made this 29th day of October, 2024 between the Local Government Unit of Tinglayan represented by HON. SACRAMENT S. GUMILAB – Municipal Mayor of Tinglayan, hereinafter called the "Entity" and MA BUYAGAN CONSTRUCTION SERVICES represented by Mr. Murphy A. Buyagan – Manager hereinafter call the "Contractor";

WHEREAS, the Entity is desirous that the Contractor execute to commence IMPROVEMENT OF ALL COMMUNITY IRRIGATION SYSTEM AT BUSCALAN, TINGLAYAN KALINGA PROVINCE with an appropriation amount P 20,000,000.00 hereinafter called "the Works" and the Local Government Unit of Tinglayan has accepted the Bid in the amount of Nineteen Million Nine Hundred Forty Four Thousand Sixty Pesos and Twenty Tree Centavos Only (Php 19,944,065.23) by the Contractor for the execution and completion of such works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Condition of Contract hereinafter referred to.
- 2. The following documents as required by the revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, to viz.:
 - (a) General and Special Condition of Contract;
 - (b) Drawing/Plans;
 - (c) Specifications;
 - (d) Invitation to Apply for Eligibility and to Bid;
 - (e) Instructions to Bidders;
 - (f) Bid Data Sheet;
 - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
- (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conform thereto; and
- (l) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. MA BUYAGAN CONSTRUCTION SERVICES agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of Nineteen Million Nine Hundred Forty Four Thousand Sixty Five Pesos and Twenty Tree Centavos Only (Php 19.944,065.23) or such other sums as may be ascertained, MA BUYAGAN CONSTRUCTION SERVICES agrees to commence the work – IMPROVEMENT OF ALL COMMUNITY IRRIGATION SYSTEM AT BUSCALAN, TINGLAYAN KALINGA PROVINCE in accordance with his/her/its Bid.

4. The Local Government Unit of Tinglayan agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
