The BAC will use non-discretionary pass/fail criteria in the eligibility check/screening as well as the preliminary examination of bids. The BAC conducts post-qualification of the lowest calculated bid.

All particulars relative to Eligibility Statement and screening, Bid Security, Performance Security, Pre-bid conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of RA 9184 and its Implementing Rules and Regulation (IRR).


