CONTRACT AGREEMENT

THIS AGREEMENT, made this 22nd day of October, 2024 between the Local Government Unit of Tinglayan represented by HON. SACRAMENT S. NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Condition of Contract hereinafter referred to.

- (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- (k) Notice of Award of Contract and the Bidder's conform thereto; and
- (1) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>SAGADANIAN BUILDERS agrees that additional</u> contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of Fourteen Million Nine Hundred Ninety One Thousand Seven Hundred Seventy Seven Pesos and Nine Centavos Only (Php 14.991,777.09) or such other sums as may be ascertained, SAGADANIAN BUILDERS agrees to commence the work -CONSTRUCTION OF EVACUATION CENTER/ BARANGAY GYMNASIUM at LOCCONG, TINGLAYAN KALINGA PROVINCE in accordance with his/her/its Bid.
 - 4. The Local Government Unit of Tinglayan agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
