

## CONTRACT AGREEMENT

THIS AGREEMENT, made this 24<sup>th</sup> day of FEBRUARY, 2022 between the Local Government Unit of Tinglayan represented by **HON. SACRAMENT S. NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


