

CONTRACT AGREEMENT

THIS AGREEMENT, made this 19th day of March 2024 between the Local Government Unit of Tinglayan represented by **HON. SACRAMENT S. GUMILAB** - Municipal Mayor of Tinglayan, hereinafter called the "Entity" and NORTHPOINT PHARMA AND MEDICAL SUPPLIES TRADING represented by Mr. Gelico Mamauag Camaddu.

WHEREAS, the Entity is desirous that the Supplier execute the **PROCUREMENT OF DRUGS AND MEDICINES OF RHU TINGLAYAN** from the Fund of MOOE RHU 2024 FUND with an appropriation amount **P 500,060.00** hereinafter called "the PROCUREMENT" and the Local Government Unit of Tinglayan has accepted the Bid in the amount of FIVE HUNDRED THOUSAND AND TWENTY PESOS ONLY (**Php 500,020.00**) by the Supplier for the execution and completion of such goods and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Condition of Contract hereinafter referred to.
2. The following documents as required by the revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, to viz.:
 - (a) General and Special Condition of Contract;
 - (b) Invitation to Apply for Eligibility and to Bid;
 - (c) Instructions to Bidders;
 - (d) Bid Data Sheet;
 - (e) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (f) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - (g) Eligibility requirements, documents and/or statements;
 - (h) Performance Security;
 - (i) Notice of Award of Contract and the Bidder's conform thereto; and
 - (j) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **NORTHPOINT PHARMA AND MEDICAL SUPPLIES TRADING agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of FIVE HUNDRED THOUSAND AND TWENTY PESOS ONLY (**Php 500,020.00**) or such other sums as may be ascertained, **NORTHPOINT PHARMA AND MEDICAL SUPPLIES TRADING** agrees to deliver the **DRUGS AND MEDICINES OF RHU TINGLAYAN** in accordance with his/her/its Bid.

4. The Local Government Unit of TINGLAYAN agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


