CONTRACT AGREEMENT

THIS AGREEMENT, made this 30th day of AUGUST, 2024 between the Local Government Unit of Tinglayan represented by HON. SACRAMENT S. GUMILAB – Municipal Mayor of Tinglayan, hereinafter called the "Entity" and B.M. DOMINGO MOTOR SALES, INC. represented by IOHN MARK L. NATIVIDAD.

 - (d) Bid Data Sheet;
 - (e) Addenda and/or Supplemental/Bid Bulletins, if any;
- (f) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - (g) Eligibility requirements, documents and/or statements;
 - (h Performance Security;
 - (i) Notice of Award of Contract and the Bidder's conform thereto; and
- (j) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. B.M. DOMINGO MOTOR SALES, INC. agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed. Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- 3. In consideration for the sum of One Million Nine Hundred Ninety Five Thousand Pesos Only (Php. 1,995,000,00) or such other sums as may be ascertained, B.M. DOMINGO MOTOR SALES, INC, agrees to deliver the 1 UNIT BRAND NEW RESCUE VEHICLE in accordance with his/her/its Bid.
- The Local Government Unit of TINGLAYAN agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
